

# Gove's 'Levelling Up' White Paper

The Times newspaper, 3 January 2022, carried a briefing on the likely contents of the 100 page White Paper promised for early this year on the government's Levelling Up programme. The target is that every region in England would have a local leader with powers equivalent to the London mayor within eight years. In county areas where the term mayor might be inappropriate there would be a 'governor'. The minimum population will be 500,000. There is also likely to be a Central Government oversight body, similar to the Office for Budget Responsibility, with powers to monitor all government actions with reference to their impact on regional inequalities. The Levelling Up fund remains at  $\pounds$ 4.8 billion.

#### Welsh Labour's election programme April 2021

Lord Foulkes of Cunnock To ask Her Majesty's Government what discussions they have had with the Welsh Government about the independent commission set up by that Government to look at options for the future constitution of Wales.

Baroness Bloomfield of Hinton Waldrist [for UK government]

My Lords, the UK Government have not yet had any discussions with the Welsh Government regarding the independent constitutional commission; nor were we informed of its proposed structural content. But we were aware that this was a manifesto commitment. In subsequent written communication with the Minister for Intergovernmental Relations, the First Minister of Wales stated that he would encourage the commission to contact the UK Government, and we hope to be able to give evidence.

Lord Foulkes My Lords, does the Minister agree that, while the constitution is a matter reserved to this Parliament, it is helpful that the Welsh Government have set up this independent commission to make recommendations? However, if the governance of Wales, the governance of Scotland and the governance of Northern Ireland are considered in isolation, there is an increased risk of the breakup of the United Kingdom. So will the UK Government now consider some form of review of the governance of the whole of the United Kingdom, including England, in a systematic and coherent way, so that we can ensure the continued prosperity and unity of this United Kingdom? *Baroness Bloomfield of Hinton Waldrist* 

As always, the noble Lord makes a very compelling case. The UK Government are committed to protecting and promoting the combined strengths of our union, building on hundreds of years of partnership and shared history. This Parliament remains in charge of the balance between reserved and devolved competences, and we will continue to make sure that our constitutional arrangements remain fit for purpose and enable our institutions to work effectively together to deliver for citizens in every part of the UK. We have no plans for a UK-wide constitutional convention.
